ELECTION ARTICLES

ARTICLE 1: To elect a moderator to preside at said meeting.

ARTICLE 2: To elect a Selectperson to a term of three years. Joe Babbitt's Term has expired.

ARTICLE 3: To elect a representative to The School Committee for a term of 3 years A seat is vacant.

MUNICIPAL ARTICLES

ARTICLE 4: To see if the Town will vote that taxes shall be due and payable on or before November 17, 2025 or 30 days after Tax Commitment. All unpaid taxes after December 30th, 2025 will be charged interest at 7.00% on all unpaid balances.
